General Rules

There are some exceptions to these rules. Please download complete Show Rules from website.

JUDGE'S DECISION IS FINAL
 Show is open to all breeds of horses, ponies, donkey or mule.
 Stallions MUST be handled by an adult 18 years or over or by breed rules. Open classes are open to any horse or exhibitor.
 Any abuse or inhumane treatment will not be tolerated.
 You may be asked to leave & forfeit your entry fees.
 Boots & Long Sleeved Shirts (short sleeves, due to heat, at the Judge's discretion) are mandatory in all classes.
 NO DOGS OR ALCOHOL ALLOWED.

Safety helmets are suggested for all classes and required for all hunter attired 17 & under exhibitors.
 Two hands are to be used on a snaffle or bosal on a Junior horse ONLY.
 One hand on a shank bit. NO training aids allowed!
 No refunds or credits on scratched classes or any other paid fees without a veterinary excuse.
 All classes added the day of the show must be done in the show office a minimum of 3 classes prior. NO ENTRY AT THE GATE.
 All persons and exhibitors under the age of 18 must have adult supervision.
